<b>What is the overall <u>deductible</u>?</b>	<b>\$100</b> individual / <b>\$200</b> family medical combined <u>in-network</u> and <u>out-of-network</u>	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
<b>Are there services covered before you meet your <u>deductible</u>?</b>	Yes. Well child care, prenatal care and <u>in-network preventive care</u> services are covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost-sharing</u> and before you meet your <u>deductible</u> . <b>What is the <u>out-of-pocket limit</u> for this plan?</b>	<b>\$1,000</b> individual / <b>\$2,000</b> family medical combined <u>in-network</u> and <u>out-of-network</u> <b>\$300</b> individual / <b>\$500</b> family drug combined <u>in-network</u> and <u>out-of-network</u>	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services.
