Dear residents and fellows,

Your current benefits will terminate at the end of the month in which you complete your residency or fellowship, but you are eligible for COBRA benefits on the first day of the following month.

COBRA enrollment must be completed within 60 days of your last day of coverage. Enrollment information and forms can be found on the Office of Student Health Benefits [website](#).

You may stay enrolled in COBRA for up to 18 continuous months. COBRA coverage must be with the same plan option you had as of the date of coverage termination. COBRA payments and cancellations are administered by BRI, LLC.

As part of your University-sponsored disability insurance plan, you have a time-sensitive and unique opportunity to convert to an individual disability policy, the Guaranteed Standard Issue (GSI) option, through Foster Klima. You may enroll in the conversion opportunity anytime during or up to 90 days after the completion of your residency or fellowship.
